Answer 1	No, rows 2 and 3 are only to be completed if the answer in row 1 is "yes".						
Question 2	Section 1.12 The prequalification material states that you wish to receive "One signed original in paper form". What is meant by this?						
Answer 2	It means that one paper version of the application must be submitted with signatures where stated (i.e. appendices 3A and 3B, and appendix 2C if this appendix is relevant)						
Question 3	Do you wish us to submit prices for the prequalification or do you only wish us to submit information on financial and technical capacity?						
Answer 3	Prices are NOT to be submitted in the prequalification process. Only the information requested in the prequalification material is to be submitted. Prices are not relevant until the next phase of the tender.						
Question 4	Appendix 2, section 2.1 It states: "Does the applicant base its activities on the economic and financial capacity of another business?" Could you elaborate on this?						
Answer 4	The quoted passage refers to section 1.8.2, bullet no. 3 of the prequalification material. For the purposes of the prequalification material an applicant "bases its activities on the economic and financial capacity of another business" if, for the prequalification evaluation process, the applicant wishes emphasis to be put on the financial capacities of another business, e.g. a supplier or a parent company.						
Question 5	Appendix 2, section 2.1 As we are one of the world's largest manufacturers of sensors (RFID, optic, capacitive, magnetic, etc.) we also manufacture other kinds of electronic equipment than the equipment demanded in the tender (RFID equipment). In this light, is our answer to the passage quoted in Question 4 yes or no?						
Answer 5	It is the sole decision of the applicant whether it wishes the contracting entity to take the financial capacity of another business into consideration when considering the applicant for prequalification. Consequently, only the applicant can decide whether						

	the answer to the question is yes or no.
Question 6	Appendix 2, section 3.5: Same question as questions 4 and 5
Answer 6	The mentioned passage refers to the last bullet in section 1.8.3 of the prequalification material. For the purposes of the prequalification material an applicant "bases its activities on the technical capacity of another business" if, for the prequalification evaluation process, the applicant wishes emphasis to be put on the technical capacities of another business, e.g. a supplier or a parent company. It is the sole decision of the applicant whether it wishes the contracting entity to take the technical capacity of another business into consideration when considering the applicant for prequalification. Consequently, only the applicant can decide whether the answer to the question is yes or no.
Question 7	Could you please specify which kind of cables lot no. 4 (cables between RFID readers and Antennas) concerns? If the cables are of a certain complexity it will be of interest to us. If, on the other hand, the tender concerns ordinary PDS-cables, for instance pulling and fixture of patch-cables, we shall refrain from applying for prequalification.
Answer 7	The cables will be coax cables.
