Lower Silesia is developing very rapidly and it has one of the most modern and attractive economies in Poland. It also closely cooperate with several European regions what is based on established partnership agreements. To meet the chance created by dynamic economic growth and real partnership, as well as the challenges of sustainable development, Marshal's Office of Lower Silesia decided to create the project *Partnership for Good – P4G* in the framework of Norwegian Financial Mechanism (Priority 9: Regional policy and cross-border activities).

The main aim of our project is to improve not only over-border cooperation but also public communication in order to implement regional policy and development management. The most significant advantages deriving from implementation of the project:

- Creating strong partnerships between institutions from participating regions.
- Activities promoting regions and benefits of common use of the internet platform.
- Knowledge exchange during study visits and summer school.
- Exchange of best practice promoting regional development within the task force.
- Visits and promotional events organized by partners.

In order to achieve this targets we would be really grateful for support in following measures: merit and language support for preparing promotional materials and presentations in subject maters, merit and language support for internet platform, competent assistance for visitors during study visits, active participation in task force.

All the costs of your stay in our region will be covered by Norwegian Financial Mechanism or Marshall's Office of Lower Silesian Voivodship. The costs of study visits will also be covered by the project funds. When the project is approved, Marshal's Office of Lower Silesia as a lead partner, is obliged to: cover the costs incurred by project partners during visiting of Lower Silesia, manage the project, to coordinate the task force, to organize conferences and summer school, to prepare promotional publications and materials.

Your financial contribution to the project would include your travel expenses or additional promotional activities related directly to your region.
